The natural gas deliveries must be of H-gas quality and meet the specifications set out in DVGW work-sheet G 260. The schedule for the delivery period from 01.01.2026, 6:00 hrs, to 01.01.2027, 6:00 hrs, is set out in Annex 1.

The total quantity is **61,320.0 MWh**.

The price to be paid by Thyssengas to the supplier results from the price to be paid for the respective delivery day "EEX THE Day Ahead and Weekend" plus the price surcharge specified by the supplier or minus the price markdown specified by the supplier (Annex 1). "EEX THE Day Ahead and Weekend" is the daily reference price (End of Day) that is published on the EEX homepage for the market area THE in €/MWh for all gas days of the delivery period (as of the date of this offer form this can be found on the website „[www.eex.com/en](http://www.eex.com/en)“ under the heading "Market Data > Market Data Hub > Natural Gas > Spot > THE Day Ahead resp. THE Weekend > End of Day").

The procedural terms (version as of 16.05.2022) shall apply and are hereby explicitly acknowledged, especially the period of validity of an offer.

The provisions contained in the master agreement concerning the supply of fuel gas (version as of 18.09.2025), as concluded between Thyssengas GmbH and the supplier, are an integral part of this offer to conclude an individual contract and are hereby explicitly acknowledged.
